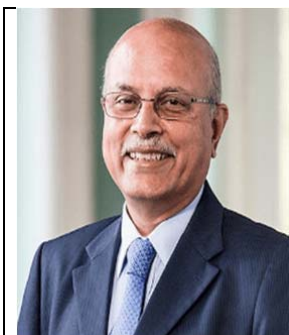

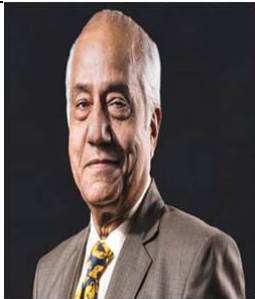

Hon. Justice B.N. Srikrishna started his career as an advocate in Bombay High Court in 1962 and later served as a judge of the Bombay High Court from 1990 till 2001 when he was appointed as the Chief Justice of the High Court of Kerala. He was appointed as a judge of the Supreme Court in 2002 and served until his retirement in 2006.

Apart from being one-man Commission to inquire in to Mumbai communal riots, Justice Srikrishna has headed several high-profile commissions such as the Sixth Pay Commission, the Committee for Bifurcation of Andhra Pradesh, Financial Sector Legislative Reforms Commission (FSLRC), the expert Committee on Arbitration in India, and Committee on Data Protection framework. Justice Srikrishna is currently the vice-president and a trustee at Bharatiya Vidya Bhavan and a trustee at the India International Centre. In the past, he has been an Independent Director of the National Stock Exchange of India Ltd. and Director of NSDL e-Governance Infrastructure Ltd and the National Securities Depository Ltd.

His familiarity with capital markets, also comes in handy for choosing him to committees related to finance and businesses








Dr Anand Deshpande
